Updating Fire Protection Plans

Over the past six years, IWA has been implementing a plan to upgrade water mains to sufficient size to allow installation of fire hydrants for all areas of Sanibel and Captiva. The plan calls for the eventual installation of a fire hydrant within 1,000' of all principal structures. This distance is safely allowed by the equipment of the Fire Departments on the islands.

While almost seven miles of piping have been installed, there are still many areas of Sanibel and Captiva where mains are too small for hydrants. Another ten miles of larger pipes are needed.

The plan continues to be implemented on a cost/benefit priority schedule with \$75,000 allocated for the 1986 construction program. Each year the remaining unprotected areas are evaluated to determine the cost per dwelling unit or upgrading the system. IWA then selects those areas with the most benefit for each dollar spent or, in other words, the "most bang for the buck".

In some cases IWA may upgrade areas out of sequence in cases where there is a chronically leaking main or to coincide with other construction projects.

IWA expects the plan to be fully implemented providing water hydrant protection to every dwelling on the island within the next ten years.

Both Sanibel and Captiva were recently upgraded to a class 7 rating by the Insurance Service Office. Most insurance companies use this rating to determine their rates. However, if hydrants were recently installed in your area, you should ask your insurance company about a reduction in your premium.

Another important factor in fire protection is the amount of water available in storage tanks. National standards recommend one day's usage as adequate. In the case of Sanibel and Captiva, that would mean about 3 million gallons. IWA actually stores more than 16 million gallons which would be very helpful in the case of a major fire.

IWA is acting on asbestos question

IWA has learned of public concern that its drinking water may contain traces of asbestos fiber. Presumably this may derive from the concrete-asbestos pipe in our distribution system. None of this pipe has been installed since before 1977. The 26 miles of this pipe represents 28 percent of the total 90 miles in our system.

IWA is alert in this matter and is in compliance with EPA guidance. EPA has not found credible consistent correlation between ingestion of water-contained fibers and human cancer development. We can further report to our members that the non-acidity of IWA water and the use of an

anticorrosion agent minimizes release of fibers.

Finally a just concluded test by a certified laboratory found no trace of asbestos in IWA samples. This testing will continue.

IWA picnic Socko-Boffo event
